Such contribution shall be used for such purposes as the Board of Directors may determine from time to time including, without limitation, operating expenses, contingency funds, statutory or non-statutory reserves for capital replacement and deferred maintenance or any combination of same. The Capital Contribution shall be in addition to any sums payable to Grand Harbor Community Association in accordance with the Grand Harbor Declaration.
