AMENDMENT TO DECLARATION FOR THE FALLS AT GRAND HARBOR

- A. 1. Article IV of the Declaration is hereby amended by adding the following new section hereto:

Section 17. Disclaimer of Liability.

"All persons are hereby notified that Declarant did not install or construct the roadways or drainage or irrigation systems and related improvements within the Property and that the master Declarant of the Grand Harbor Community did so.

Furthermore, such road and systems have been in existence and operation for an extended period of time, during which Declarant did not control the Association and therefore the operations, maintenance, repair and replacement thereof.

As well, Declarant shall be the sole party entitled to determine whether any repairs, replacement or other work on such areas occasioned by the use thereof (including for construction activities) will be repaired or paid for by Declarant."
